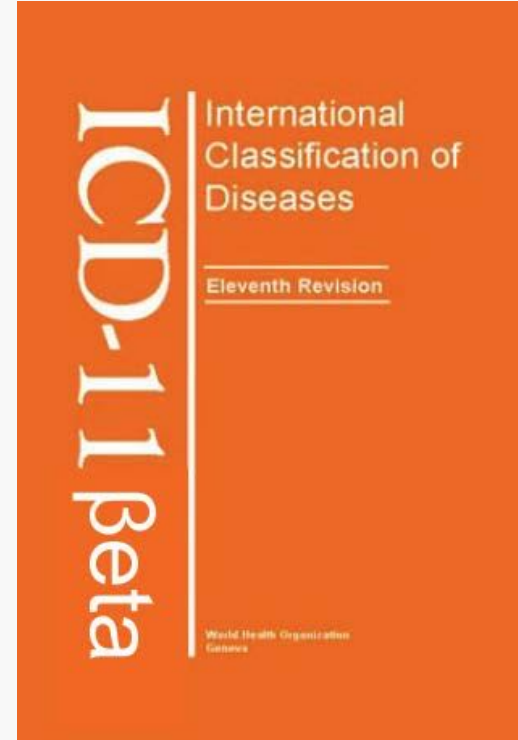

Benefits of ICD-11

- Better reflects current knowledge
- Provides enhanced coding possibilities
- Interoperability with health information systems
- Available online
- Better suit the various user needs/ multiple use cases
- Content model based
- Better linkage with other classifications/terminologies
- Available in multiple languages



ICD-11 Mortality and Morbidity Statistics (MMS)

- Used for coding and reporting illnesses or causes of death for international comparison
- 27 chapters, new chapters including
 - Disorders of the immune system
 - Sleep-Wake disorders
 - Conditions related to sexual health
 - Traditional Medicine
 - Extension codes

Stem and extension codes

- Stem code

- Up to 6 characters in length
- Categories are 4 characters in length
- Final characters Y and Z equivalent to '.8 other specified', and '.9 unspecified'

CA23.12 Non-allergic asthma, uncomplicated

- Extension code

- Appear in chapter 27
- 12 characters in length
- Can never be used alone

XH900837741 Adenocarcinoma, NOS

Pre- and Postcoordination, Cluster

- Pre-coordination
 - Stem code with all information required
- Post-coordination
 - Combine codes to give the amount of detail required
 - Stem code with stem code(s)
 - Stem code with extension code(s)
- Cluster coding
 - Grouping of post-coordinated codes
 - Separated by a '/' or '&'

Diabetic retinopathy in type 2 diabetes

9B71.0Z/5A11

Post-coordination example 2 (&)

Small cell carcinoma of left upper lobe of bronchus

2C75.1 &XA277246160 &XK271422288

The importance of testing ICD-11

- A key component of the strategy for evaluating the ICD-11 revision and informing its implementation
- Field trial objectives:
 - Test fitness of ICD-11 for multiple purposes (mortality coding, morbidity coding, etc.)
 - Identify improvements, increase consistency and fix errors
 - To ensure the stability and comparability between ICD-10 and ICD-11
 - Ensure ICD-11 is an improvement on ICD-10
 - Allow users to get acquainted with the classification

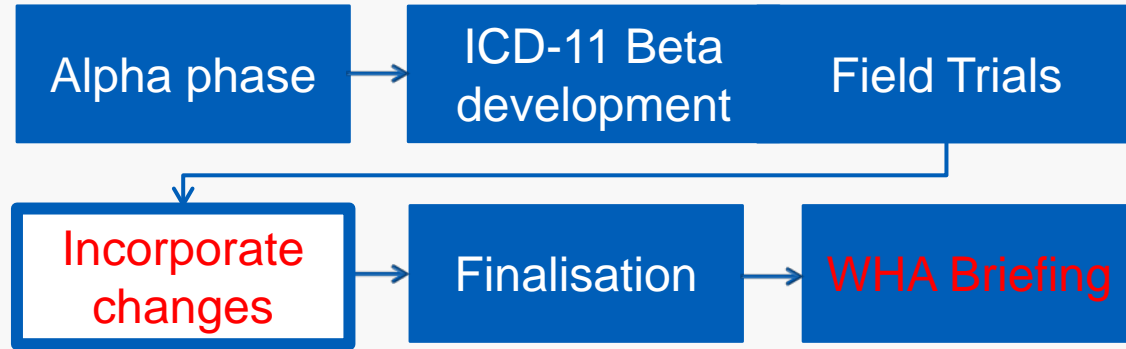
Testing performed to date

- Chapter reviews
 - Ensure structural integrity and consistency of the classification both across chapters and within chapters
- Baseline line coding exercise
 - Pre and post-coordinated concepts
- Field Trials
 - Line coding – 298 diagnoses
 - Case Coding – 30 cases

Testing Findings

- ICD-11 offers greater granularity, in some cases too much in other cases not enough
- Missing and inconsistent instructional notes
- Incorrect category numbering and unclear to what level to code to
- Coding tool and browser generally good, intuitive and easy to navigate. Some difficulties using the coding tool
- ICD-11 contains conditions not classifiable in ICD-10
- Uses current terminology
- Structured logically
- Post co-ordination functionality works well but not available everywhere
- Many of changes identified have been corrected by WHO

Current status of ICD-11



- Complete analysis of field trials
- Feed back recommendations to WHO
- Produce report containing results of field trials
