## PROCESS



## North Bristol NHS Trust

#### **Clinical Coding Training and Support Services**

North Bristol Trust (NBT) has an excellent reputation for Clinical Coding. Like most Trusts, NBT have to address the ongoing pressure of the national shortage of qualified Clinical Coders, while balancing operational delivery, Clinical Coding capacity, quality of coding output, and operating costs. To address this, we have partnered with experts at CHKS to co-design and deliver a high quality rolling annual programme to ensure a cost effective and assured means of progressing new entrants through mandated training and onto internal assessments, leading to the promotion of trainees to experienced coders. The Trust then mentors and matures coders over a further 12-18 months to achieve their national coding qualifications.

The programme has been hugely successful over the first three years; cost effective, high first-time pass rate, and has established continual improvement and staff development as a hallmark within our coding workforce. We are delighted with the success of the programme, and we are seeking to mature the development of training opportunities to embrace new technologies and accelerated learning techniques.

## Betsi Cadwaldr University Health Board

### **AI Clinical Coding**

Between 2018 and 2020 Betsi Cadwaldr University Health Board participated in a Small **Business Research Initiative** scheme looking for a solution to the resource intensive process of Clinical Coding. The Health Board worked with CHKS to develop an automation process of clinical coding based upon existing electronic health records that were available to the Health Board. The solution was innovative and had very little impact upon the department's current practices unlike some of the other proposed solutions.

CHKS provided coding and data experts that worked with the Health Boards coding team to identify areas where coding automation was thought possible.

Working together as one team a proof of concept was delivered that demonstrated that several areas within Health Board could be automated. CHKS proved incredibly knowledgeable and professional and understanding that we as a Health Board had competing work pressures. The project proved that automation was possible at ourHealth Board and the process was accurate, with higher accuracy rating than human coders achieved. The project also proved that it had the potential to provide savings on investment.

## North Lincolnshire and Goole NHS Trust (NLaG)

### **AI Clinical Coding**

The Hull University Teaching Hospitals NHS Trust (HUTH) Coding management team began to manage the NLaG coding team as part of a shared service in 2022 and the first thing that the HUTH coding management team identified was a huge gap in the clinical coding from an autocoder that the NLaG IT team had produced several years earlier.

The autocoder had been put in place due to a lack of coding resource, and initially had worked well, however the autocoder process had not been updated for years, no rules changes, new codes. An internal coding audit was undertaken and this showed a huge data quality issue that needed urgently resolving and after checking what was available, discussions started to take place with CHKS on a way forward. CHKS recommended an AI support system being produced, with an interim manual support system put in place that could be rolled out across the same areas and hopefully expanded across several areas at HUTH also. CHKS's understanding of clinical coding, the Trusts needs and their forward thinking were vital to the project from start to finish.

## Spire case study

## Managed Clinical Coding Services

#### Background

Spire Healthcare is a private hospital group with 39 private hospitals throughout the UK. Since 2012 it has been working with CHKS to continuously improve the accuracy of its coding. Martin Rennison, Director NHS Business, explains how this has improved confidence amongst NHS commissioners and also benefitted Spire's bottom line.

#### How did you improve?

Using professionally-qualified coders had an instant impact and it was clear that this was improving ourdata quality. We came to the conclusion that weshould contract out all our coding requirements to CHKS and moved all our hospitals across. At the same time we worked with CHKS on a system of quality assurance, which meant we would get monthly reports on the quality of coding followed by regular coding reviews at every hospital.

## What benefits have you seen from working with CHKS?

Working with CHKS has improved our coding which in turn means our data quality is much higher. Our coding error rate is less than 4 percent, which compares favourably with the NHS average of between seven and nine per cent. This is very important when it comes to assuring our commissioners that we are invoicing for the right activity. As a result we are being paid more promptly. Six years ago we had a 60 day debt figure of in excess of £28million and that figure now sits at around £8 million for a business twice the size. We

needed our commissioners to trust that our data and billing is accurate. We now believe it is and achieving this has improved the relationships we have with commissioners and ultimately helped to grow our business with the NHS.
